Kirby Kruger presented the proposed amendments to NDAC Chapters 33-06-05.1, 33-06-05.2, 33-06-05.3, 33-06-05.4, 33-06-05.5 and 33-06-05.5 regarding general provisions, students with significant contagious diseases, employees with significant contagious diseases, treatment of independent contractors with significant contagious diseases, relations with the public and education respectively. He requested approval and to proceed with a public hearing.

State Health Officer Update

Mylynn Tufte updated the Council on:

- US Surgeon General VADM Jerome M. Adams's visit to Bismarck, ND that included being the keynote speaker for the Main Street Summit, visited the ND Department of Health, Bismarck/Burleigh Public Health and about 600 students from the Bismarck area
- Proof of concept related to the burden of influenza by utilizing artificial intelligence
- Adding an additional medical director to the Medical Advisory Committee to the State Health Officer. It was approved by the ND Medical Association to make the recommendation to the Governor's office to add Dr. Mary Aaland to the committee.
- Establishing a Tribal Health Board in North Dakota
- Six Strategic Priorities for the ND Department of Health:
 - 1. Accountable Health State by applying the work of the Blue Zones
 - 2. Vision Zero in partnership with ND Department of Transportation & ND Highway Patrol to establish a primary seatbelt law
 - 3. Nicotine addiction relating to vaping and tobacco
 - 4. Children's Health Disparities by working with the Governor's Children's Cabinet
 - 5. Partner with long term care and the ND Department of Human Services as they look at payment reform
 - 6. Academic Department of Health by working with the university system and public health in training the workforce
