VR Region VI (Jamestown) Update

The region covers Wells, Foster, Griggs, Stutsman Barnes, Logan Lamoure McIntosh, and Dickey counties.

8 employees in the region

Growth in partnership with Developmental Disabilities and Behavioral Health. Monthly meetings with Developmental Disabilities staff. Behavioral Health invited VR to their staff meetings for the purpose of increasing successful employment outcomes for mutual clients.

Region serves 24 secondary ed, 3 vocational centers, 2 adult ed and 3 universities. Strong relationship with schools.

Challenges to employment are access to affordable housing, transportation, and childcare.

Last year met and exceeded goals. Have achieved 86% of goals with 154 of 176 application.

77% of successful closures with 58 of 74.

Average eligibility time is 19 days.

Average 44 days to plan.

VR Region VIII (Dickinson) Update

Serves 8 counties.

One counselor resigned. An intern stayed on to fill that position.

Vision Specialist has resigned.

Hybrid office – staff work from home and the office. They can offer virtual visits to clients.

Average 14 days to eligibility.

Staff meet with clients on a biweekly basis to increase engagement.

Has a Pre-ETS contract with Dickinson High School

Working to improve referrals for transition students.

They are at 98% for applications.

79% for the year on successful employment closures.

New partnership with Heartview.

Increase in Successful Closures – the highest recently by 30%

Increase in cases served.

Served more people than in entire FFY 22-23 or prior years. 36% increase from highest recent years

Completed New Provider Onboarding Packet – shared with providers and have received positive feedback.

State Plan has been submitted and approved.

Priorities framework for the Disability Employment Learning Collaborative has been submitted to NGA.

Plan on working with WDC for Accommodations Fund and for establishing a Disability Council.

Implemented Drive notes- a way of formatting the counselor's documentation.

Alicia Halle invited Mercedes Drechsel to present about her attendance at the national SRC and CSAVR.

Opportunity for an SRC member to attend the National Coalition of State Rehab Councils this fall.
