# Charter workgroup changes high level overview

## Article I – Purpose

- Some changes to the MMAC purpose language clarifying MMAC's role in reviewing and discussing changes and policies in its advisory capacity
- Added time for the review of Medicaid legislative proposals leading into a legislative session

## Article II – Composition

- Keep 25 members and clarify what kind of experience makes someone a likely candidate
- Require no less than 5 members be Medicaid beneficiaries as defined in the Charter
- Ensure broad representation by having at least one member from designated categories
- Describe types of entities that may be represented
- Reduce legislative representation from 4 to 2

# Charter workgroup changes high level overview, cont'd

## Article II – Composition, cont'd

### *Responsibilities*

- Keeping requirement to notify if members are going to be absent
- Clarifying that no member or designee can speak publicly on behalf of MMAC without permission

### *Term Limits*

- Reducing term limit from 4 years to 3
- Staggering appointments
- Members may apply for reappointment

### *Vacancies*

- Adding detail to the process of seeking appointment, will still be done via email

# Charter workgroup changes high level overview, cont'd

## Article III

- Suggested for removal because of duplication with Article II selection process

## New Article III (former IV) – Meetings

- Changed language from DHS to HHS (this happened throughout the Charter)

## New Article IV (former V) – Subcommittees

- Minor language change

## New Article V (former VI) – Review of Charter

- Changed timeframe for review from at least every other year to the July preceding a regular legislative session

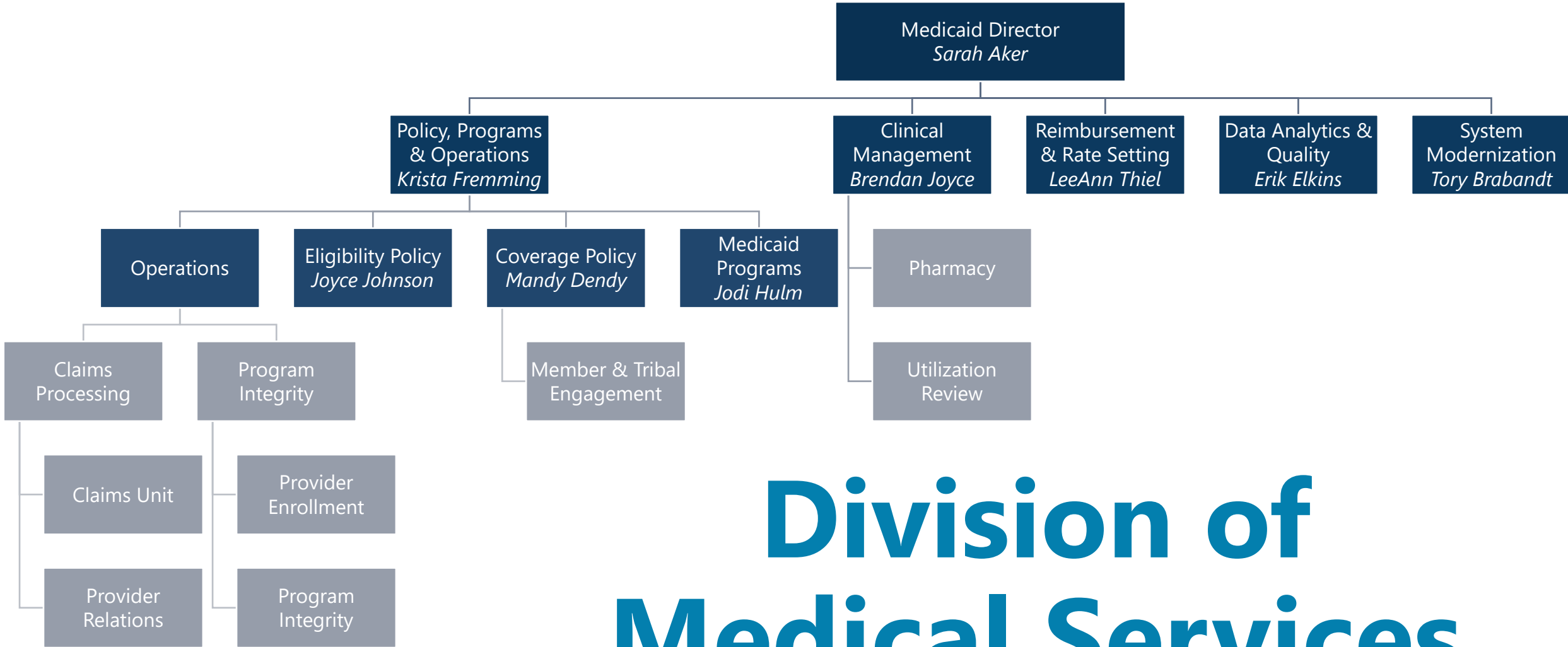

# Unaccompanied Youth and Healthcare

- [N.D.C.C. 14-10-20](#) – Unaccompanied homeless minor's consent for health care.
  - Minor 14+ living in a described situation and not in the care and custody of a parent or legal guardian
  - Can consent to, contract for, and receive medical, dental, or behavioral health examinations, care or treatment without permission, authority, or consent of a parent or guardian

# Documentation of unaccompanied homeless minor status

- [N.D.C.C. 14-10-20](#) – Unaccompanied homeless minor’s consent for health care.
  - The law lists acceptable documentation showing an individual is an unaccompanied homeless minor.
    - By a director or designee of a governmental or nonprofit entity receiving public or private funds to provide services to individuals who are homeless;
    - By a local education agency (LEA) liaison for homeless children and youth designated under law, a LEA foster care point of contact designated by law, or a school social worker or counselor;
    - By an attorney representing the individual in a legal matter; or
    - Signed statement by the individual and two adults with knowledge of the individual’s actual circumstances.

# Youth, Healthcare, and Medicaid

N.D.C.C. 14-10-20 relates to an unaccompanied youth's consent to care which is a separate thing from their access to Medicaid.



# Unaccompanied Youth and Medicaid

For Medicaid purposes, an unaccompanied youth may be considered “living independently”, which includes an individual who has:

- Lived separately and apart from both parents for at least three consecutive full calendar months after the date the individual left a parental home,
- continues to live separately and apart from both parents and
- has received no support or assistance from either parent while living separately and apart.

# Unaccompanied Youth and Medicaid

For Medicaid purposes, “child” is defined as not including individuals “living independently”.

Parental income is not counted as being actually available to an individual “living independently.”

# Unaccompanied Youth and Medicaid

We're most likely going to see unaccompanied homeless youth under Affordable Care Act (ACA) Medicaid. See [policy here](#).

- Youth can fill out the [SFN 1909](#) application on paper or apply online using the [Self-Service portal](#). They can also have [assistance](#) with the application.
  - **In foster care at age 18** - check a box if they aged out of foster care and were on Medicaid at age 18 (if so, they can be covered under Medicaid until age 26, even if they aged out of another state's foster care system)
  - (FYI **Foster care** recipient Medicaid applications are automatically done)

## What you need to know about ND Medicaid renewals

And how you can encourage members to take action!

Starting April 1, 2023, ND Medicaid may need to contact members to see if they still qualify for coverage.

### What do ND Medicaid members need to know?

ND Medicaid is working to inform members about steps they need to take to stay covered, if they qualify. These include:

-  Ensure contact information is correct.
-  Check the mail.
-  Complete their renewal form (if they get one).

### Here's how you can help:

#### 1. Share where and how to update their information.

- Contact the Customer Support Center toll-free 866-614-6005, 711 (TTY) or email [applyforhelp@nd.gov](mailto:applyforhelp@nd.gov).

#### 2. Offer assistance.

- Help them update their contact information, read and understand the letter they may receive in the mail or submit the requested documentation online. (e.g. pay stubs, income tax returns, proof of disability, etc.).

#### 3. Share resources.

- Encourage conversations about renewals and/or share resources in your community.
