## **Consideration of Select Bills**

**HB 1261 (IMD Exclusion Waiver):** BHPC Legislative Committee is opposed to IMD Exclusion Waiver. PAUL STROKLUND MADE AND EMMA QUINN SECONDED A MOTION TO OPPOSE HB 1261.

HB 1138 (Mental Health diversion pilot program): BHPC is in favor of establishing mental health courts. This bill was heard last week. BHPC will track bill and offer testimony as it progresses through the session. EMMA QUINN MADE AND PAUL STROKLAND SECONDED TO SUPPORT THE FORMATION OF MENTAL HEALTH COURTS IN NORTH DAKOTA.

**SB 2012 (NDDHHS Budget Bill):** BHPC is in favor of support NDDHHS budget bill. The bill will be heard starting on Monday, Public comment has not been scheduled at this time. MATTHEW MCCLEARY MADE AND SECONDED BY PAUL STROKLUND TO SUPPORT THE DHHS BUDGET BILL.
