


Division budgets compared to Engrossed SB 2012

2023-2025 Engrossed SB 2012 in millions






Section budget compared to Engrossed SB 2012 (in millions) Early Childhood represents 1% of SB 2012, \$38.4 million



- 2023-2025 base budget reflects original (21-23) section funding from originating sources of CFS and DPI
- 2021- 2023 appropriated budget includes federal COVID funding designated for early childhood (appropriated during both regular and special session)
- 2023 2025 Executive Budget Request included state funds to shift funding source for child care licensing staff (would change funding source from 457 to general), continuation of Waterford Upstart, and several elements of ND Child Care Proposal
- 2023-25 Engrossed SB 2012:
 - Rejected proposed funding source transfer for child care licensing staff (funds maintained in HSZ budget)
 - Removed funding for Waterford Upstart (-\$2.4 M)
 - Reduced proposed expansion of Best in Class (-\$4 M and 1 FTE)
 - Reduced child care grants and incentives (-\$2 M)
 - Reduced employer-led child care program (-\$4 M)






COVID Grants for Child Care Programs and Workforce

 - Updating and aligning early childhood **competencies**, **career pathways and expanding professional development supports to grow the early childhood workforce** from entry into the field to credentials and degrees
 - Redesign of the **quality improvement system for the early childhood mixed delivery system**
 - **Engaging families** with greater access to information they need
 - Expand infrastructure to support children's mental health and emotional well-being
- All activities complement work that is proposed in EBR; they are not duplicative of existing or proposed efforts.
