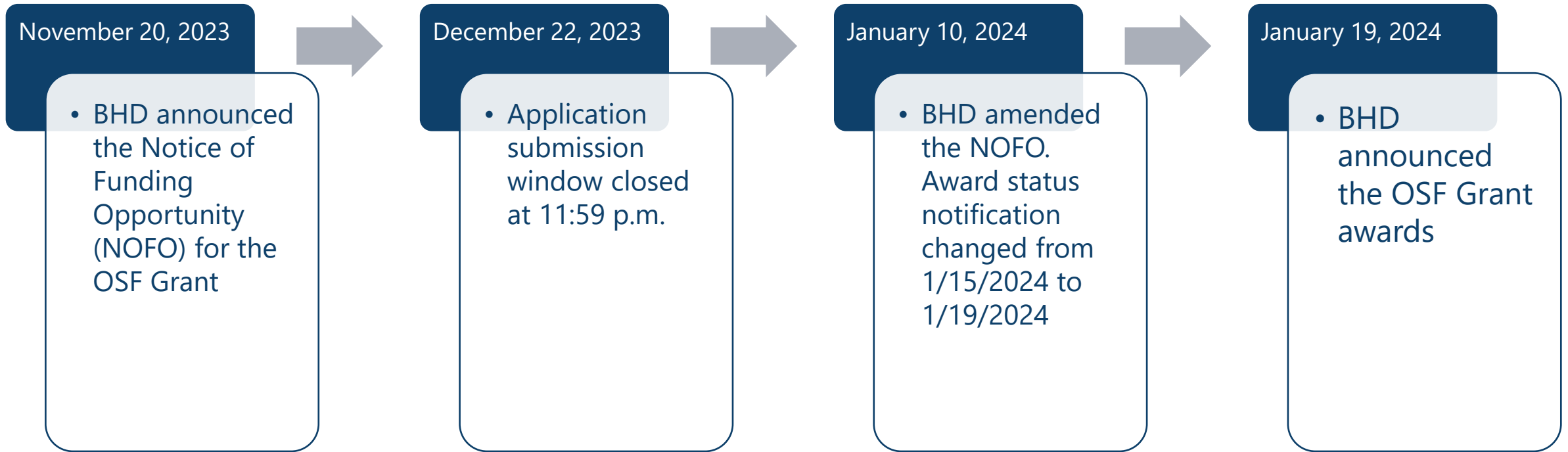

# Opioid Settlement Fund (OSF) Grant

## Background Information



Total available funding: \$7,053,787

BHD received a total of 65 applications with requests for funding equaling \$59,556,660.18

BHD awarded 14 programs/organizations



# **Awarded Applicants for the OSF Grant**



As outlined in NDCC 50-36-05, at least 20% (\$1,600,000 of the \$8,000,000 settlement funds appropriated for the 2023-2025 biennium) shall be used for opioid use prevention and overdose prevention, including best practices relating to fentanyl drug overdose, and approved use for workforce development.

Nelson-Griggs District Health Unit	\$21,600	Standardize patient screenings for opioid use disorder and create a system for referral with the local hospitals, clinics, Sheriff's offices and ambulance squads in the counties of Nelson and Griggs

Central Valley Health District	\$37,409	Implement a Syringe Service Program within an office at the South Central Human Service Center (Jamestown) to help individuals with a substance use disorder connect to treatment and recovery services.
Community Connect Program	\$3,946,136.96	Expand access to the community-based behavioral health program designed to provide behavioral health support services to individuals through the provision of care coordination and peer support in their North Dakota community. All funding will be provided directly to providers.
Community Medical Services (CMS)	\$452,389.04	Support the Opioid Treatment Program (OTP) in Grand Forks to connect individuals in need of opioid use disorder to evidence-based treatment services.
Endeavour Sober Living	\$535,000	Provide a safe and supportive environment for women and pregnant and parenting women by establishing a recovery house in Minot, ND.
First District Health Unit	\$66,681	Expand the Syringe Service Program in Minot, N.D., by adding additional service hours, to help individuals with a substance use disorder connect to treatment and recovery services.

NE Central Judicial District Drug Court (GF)/Department of Corrections and Rehabilitation	\$51,000	Provide substance use disorder treatment services and coordination of care to individuals involved in the Northeast Central Judicial District Drug Court in Grand Forks.
Richland County Treatment Court	\$134,000	Provide substance use disorder treatment services and coordination of care to individuals involved in the Richland County Treatment Court.
USpireND	\$130,075	Expand the Healthy Families ND program to reach parents who are incarcerated. Healthy Families North Dakota is a state-wide evidence-based home visiting program that focuses on improving maternal and child health, while also supporting child development and family economic self-sufficiency.
