OSF Grant Highlights

Endeavor Sober Living – Continuing to support pregnant and parenting women in recovery within their recovery home. Since March, 18 women have received support with 6 of those women reunified with their children. Plans to open an additional home.

USpire – Continuing to support parents and family units, including parents who are incarcerated. Since March, 47 family units have been supported with 17 units reaching their goals set within the program.

Heartview/TAAP – Continuing to enhance the behavioral health workforce. Since February, 41 addiction counselor trainees have been supported with scholarships or training stipends, 15 new clinical supervisors have been added to the program, and 11 addiction counselors have been licensed in the state.

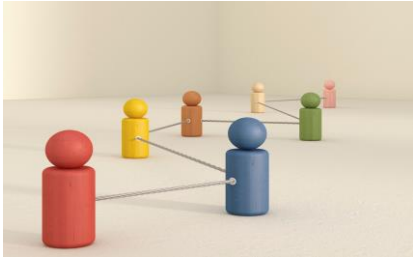
ONE Program – Continuing to increase access to naloxone and prevent harm related to opioids in tribal communities. Since February, 171 ONE Boxes (Narcan) have been placed.

Community Connect – From February – May, 845 individuals have received services through the Community Connect program.

Sanford Medical Center Fargo – Continuing to integrate behavioral health by becoming licensed to provide outpatient Substance Use Disorder Treatment services. The facility has 18 prescribers actively prescribing medications for opioid use disorder.

State Opioid Response (SOR) Grant

The purpose of North Dakota's State Opioid Response (SOR) grant is to address the public health crisis caused by escalating opioid misuse, opioid use disorder (OUD), and opioid-related overdose by increasing access to FDA-approved medications for the treatment of opioid use disorder (OUD), and for supporting the continuum of prevention, harm reduction, treatment, and recovery support services for opioid use disorder (OUD) and other concurrent substance use disorders.

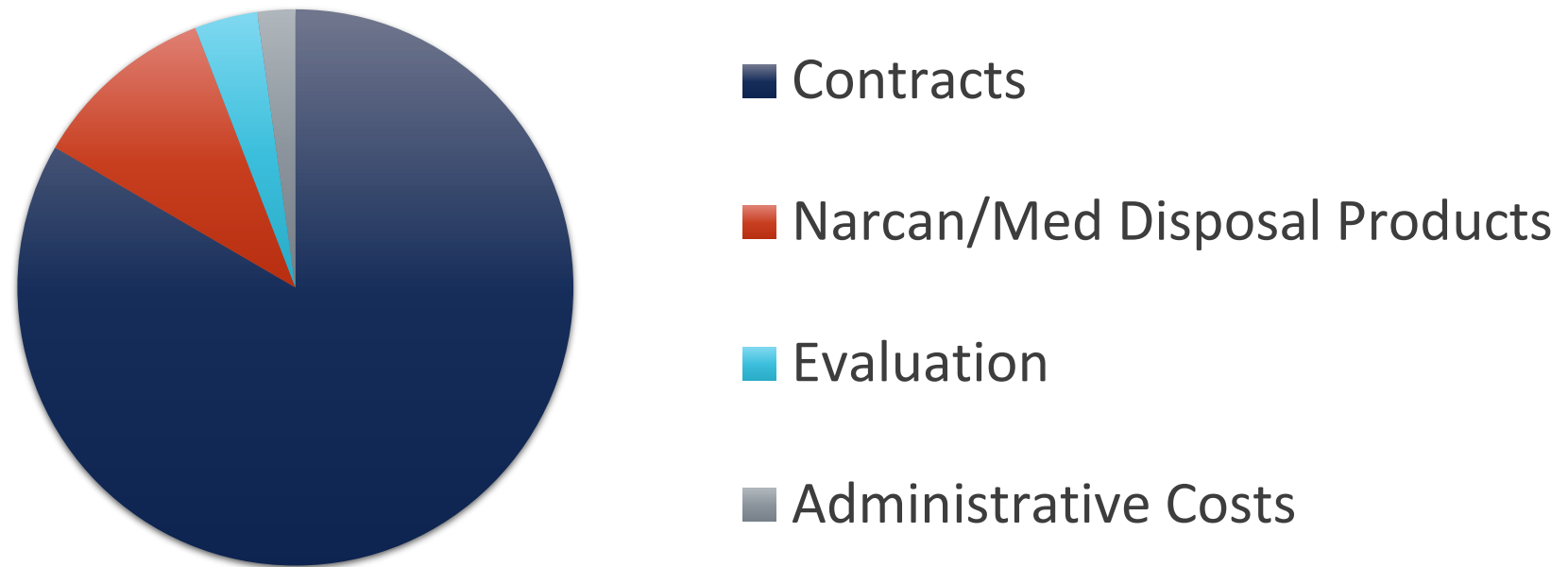

Annual Funding Allocations



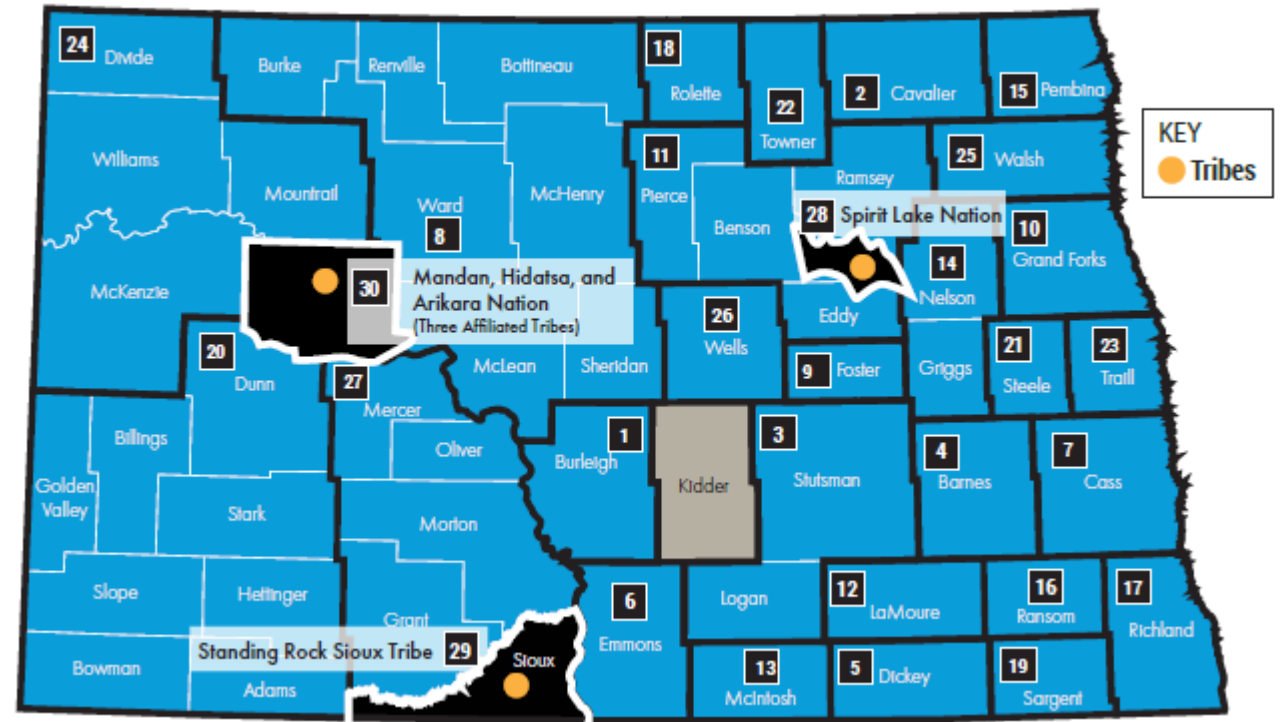
