# **Opioid Settlement Updates –** ND AG's office

• The first year of payments were made under the Teva, Allergan, CVS, Walmart, and Walgreen settlements on February 26 and April 22, in the total amounts of approximately \$6.2 million to the state and \$1.1 million to the Counties/Cities.

• The State reached a settlement in the form of a Consent Judgment with Publicis Health, a marketing company that marketed opioids for several opioid manufacturers. We received full payment in the amount of approximately \$590,000 from that settlement in April.

### **Opioid Settlement Fund – Spend to Date**

\$8,000,000 of Opioid Settlement Funds were appropriated to DHHS for the 23-25 biennium

- \$7,053,787 was allocated for the Opioid Settlement Fund (OSF) Grant
- \$946,213 was allocated for State Opioid Response tribal contracts, Narcan purchasing, and administration

#### As of 5/31/2024:

- \$1,330,432.59 has been spent for the OSF Grant
- \$546.26 has been spent for administration costs

Total of \$1,330,978.85 in Opioid Settlement Funds spent to date

### **OSF Grant Updates**

**Endeavor Sober Living** – From March-May, 14 new pregnant or parenting women have been supported in their recovery journey and 4 moms were reunified with their child(ren)

First District Health Unit's Syringe Service Program – added an additional 3 hours of services each week and 13 new people received services during March-May because of the additional hours

**USpire** – From March-May, served 78 family units with 11 of those units involving individuals who are incarcerated. Services reached Burleigh, Morton, Stark, Hettinger, Cass, Grand Forks, Dickey, Stutsman and Barnes counties (n=9)

**DOCR Grand Forks Treatment Court** – From March -April, served 18-33 people at a time with 5 new individuals served during the timeframe. Eight individuals saw an improvement in employment status and 7 people saw an improvement in their housing situation

**Heartview/TAAP** – Since February, added 4 new Licensed Addiction Counselor (LAC) training sites, added 13 new clinical supervisors, and provided stipends to 5 LAC trainees

**ONE Program** – Since February, installed 76 ONE Boxes (Narcan) in tribal communities

**Community Medical Services** – Since March, served 22 new individuals

**Community Connect** – From February – May, 614 individuals have received services through the Community Connect program.



## Opioid Settlement Fund – Investment updates

In May, the State Investment Board (SIB) approved the investment of the Opioid Settlement Fund.



### **Subdivision Allocations and Plans**

### As of 4/4/2024:

- Subdivisions have received a combined total of \$2,278,852.37
- 32 subdivisions submitted an allocation plan
- 25 subdivisions have not submitted an allocation plan
- 7 subdivisions did not participate in the settlement
