The contract will run from October 1, 2023, through September 30, 2026. The contract period will be broken into four phases:

- Phase 1: Assessment Phase, October 1, 2023 – November 30, 2023
- Phase 2: Planning Phase, December 1, 2023 – December 31, 2023
- Phase 3: Implementation Phase, January 1, 2024 – July 31, 2026
- Phase 4: Evaluation Phase, August 1, 2026 – September 30, 2026

Next Steps:

The State will begin the contract initiation process starting September 25th, 2023 and will be reach out via e-mail to the primary contact listed on the ITA application form if any additional information is needed.

A virtual New Contract Kickoff Meeting is scheduled for Monday, October 16th, 2023 at 10:00am for two hours via Teams. An e-mail invitation will be sent out to all contacts listed on the ITA application form. This meeting will provide introductions and discuss several topics such as a detailed scope of the grant, contract, requirements, important dates, process changes, and and provide the opportunity to answer any questions. We will also be e-mailing out important documents for the new contract period prior to this meeting, including a brand-new Contract Resource Guide!
