Behavioral Health Planning Council Legislative Committee

Friday, January 15, 2021 11:00 AM, CT

Call to Order. Greg Gallagher, Facilitator, called the business meeting of the BHPC Legislative Committee to order at 11:05 AM, CT.

Members Present. Brenda Bergsrud; Emma Quinn, Kurt Snyder, Teresa Larsen.

Facilitator. Greg Gallagher, The Consensus Council.

Legislative Committee Charge. Greg Gallagher provided background information regarding (a) the December 16, 2020, Committee meeting which defined the work and priorities of the Committee and (b) the December 29, 2020, and January 8, 2021, Committee meetings which reviewed select legislative issues, including the state hospital project. Members revisited the charge of the Legislative Committee, including (1) identifying prospective legislative initiatives aligned with the purpose of the BHPC; (2) monitoring legislative initiatives through the legislative process; (3) coordinating communications with BHPC members and facilitating effective BHPC input throughout the process; (4) soliciting the active participation of BHPC members; (5) drafting legislation that might advance the aims of the BHPC and the state's behavioral health strategic plan; and (6) empowering the BHPC Legislative Council, with full participation of the BHPC Executive Committee, to transact legislative activities that support the aims of the BHPC.

Mr. Gallagher identified several meeting agenda items:

- (1) assess the BHPC Legislative Committee's satisfaction with its current operational plan;
- (2) expand Committee discussions by inviting BHPC members to observe and provide input during the Committee meetings;
- (3) clarify the issuance of a public notice to all BHPC Legislative Committee meetings;
- (4) review the Department of Human Service's executive budget (HB 1012), including the state hospital appropriation, among other initiatives previously discussed;
- (5) identify <u>specific bills</u> to be considered during the next legislative week that might require BHPC testimony.

Members agreed to the outlined agenda and requested the discussion of HB 1089 and HB 1318, scheduled for legislative committee work, next week.

Members reviewed and acceded to the January 8, 2021, BHPC Legislative Committee meeting minutes.

BHPC Legislative Committee Operational Plan. Members expressed satisfaction with the current standing and articulation of BHPC legislative initiatives.

Expanding BHPC Legislative Committee Participation. Committee members expressed support for announcing the schedule of the Committee's weekly Friday-morning sessions to the BHPC membership. Mr. Gallagher will issue weekly invitations for members to attend. The Committee will retain its defined role as operational managers for the Committee meetings, inviting other BHPC members to observe and participate in keeping with the established agenda and time constraints of the meeting's proceedings.

Clarify Issuance of Public Meeting Notices. Committee members concurred with a recommendation from Mr. Gallagher that all BHPC Legislative Committee meetings be announced in the same manner and forum as any full BHPC meetings, as specified in state law. Mr. Gallagher will work with Tami Conrad, BHPC project manager within DHS, to manage the issuance of meeting notifications with the public information staff of the Department of Human Services.

Expressed Support for <u>HB 1089</u>. Members reaffirmed support for <u>HB 1089</u>, approved during the January 8, 2021, Committee meeting. Teresa Larsen agreed to draft and submit testimony, on behalf of the BHPC. HB 1089 originates as a DHS initiative. Ms. Larsen will submit the written testimony without any accompanying oral testimony. HB 1089 is scheduled for a public hearing on January 18, 2021, before the House Human Services Committee.

Expressed Support for HB 1318. Members reviewed and discussed support for HB 1318, a bill requiring local school districts to adopt written seclusion and restraint policies. This bill is the most recent effort to enact a state-mandated seclusion and restraint policy. Currently ND is one of four states in the Nation without a seclusion and restraint school policy.

EMMA QUINN MADE AND KURT SNYDER SECONDED A MOTION FOR THE BEHAVIORAL HEALTH PLANNING COUNCIL TO DRAFT TESTIMONY IN SUPPORT OF HB 1318. THE MOTION PASSED UNANIMOUSLY. CHAIRPERSON BERGSRUD ANNOUNCED THE PASSAGE OF THE MOTION.

Teresa Larsen agreed to draft support testimony for HB 1318, on behalf of the BHPC, which Brenda Bergsrud will submit and perhaps provide oral testimony. HB 1318 is scheduled for a public hearing on January 19, 2021, before the House Education Committee.

Review of DHS Executive Budget, HB 1012. Members discussed the best means of providing BHPC testimony regarding HB 1012, the DHS Executive Budget, during the bill's public comment hearing, during January 25-26, 2021. Members agreed that it was important for the BHPC to provide broad guiding testimony, as the state's principal advisory council on behavioral health, to optimize the proper continuation of increased state behavioral health appropriations, which have been hard-fought for the past decade. Members stated that it was better to state broad funding goals than to enter into a program-by-program, line item-by-line item assessment, which might derail overall advances.

Members agreed that the BHPC should submit and provide supporting oral testimony on HB 1012, that combines, within a unifying narrative, both general guidance regarding behavioral

heath appropriations and support for the proposal to build a new state hospital. Members reaffirmed the intention of the BHPC to provide supportive testimony for the building of a new state hospital, agreed to during the January 8, 2021, Committee meeting.

Members reaffirmed the four core budgetary principles the Committee established in its December 16, 2020, meeting:

- Protect Existing Programs from Possible Budget Cuts. Members expressed an interest to sustain, minimally, the state's current funding levels for behavioral health programming. Members identified a need to carefully review the forthcoming DHS budget to ascertain budget priorities, including the anticipated impact of reallocations brought on by the implementation of the state's Medicaid 1915(i) plan.
- Support of Medicaid Expansion. Members reiterated the BHPC's support for the continuation of the state's Medicaid Expansion program, as reaffirmed during the December 9, 2020, meeting of the BHPC. Members seek to remove any sunset clause to the state's Medicaid Expansion, securing a service safety net into the future.
- Establishing a Balance Between Substance Use and Mental Health Efforts. Members identified a need to establish a programmatic and budgetary balance that supports both substance use disorder and mental health initiatives, forestalling any inequitable redistribution of funds that might introduce disparity.
- Assessing the Balanced Use of Federal and State Funding. Members expressed a need to learn more about the manner in which DHS or other state agencies are optimizing the use of both federal and state funding and resisting any effort to transfer funding inordinately from state to federal responsibility. Both funding sources are important and should be optimally used.

Brenda Bergsrud and Emma Quinn will co-author the HB 1012 testimony, which will be submitted by Ms. Bergsrud, with supporting oral testimony. It is anticipated that public comment for all DHS executive budget matters will be heard during January 25-26, 2021, by the House Appropriations Committee-Human Services Section.

The BHPC Legislative Committee agreed to meet again on Friday, January 22, 2021, at 11:00 AM, CT, to continue its work.

Adjournment. Having complete the stated aims of the meeting, Chairperson Bergsrud called the meeting adjourned.

The meeting adjourned at 12:18 PM, CT.
