# LIFE SKILLS AND TRANSITION CENTER (LSTC)



### **QUICK FACTS**

O Accredited by The Council since 1989. Received a four-year Person-Centered Excellence Accreditation in December 2019. • Serves as a crisis and stabilization center, as well as a safety net for people whose needs exceed community resources.



The Life Skills and Transition Center (LSTC) is a state-operated, comprehensive support agency serving people with intellectual and developmental disabilities in Grafton.

People supported by the LSTC may reside in an intermediate care facility (ICF) setting on campus, in residential habilitation homes in the Grafton community, or in communities across the state. Admissions are meant to be short term. Off-site outreach and consultation services are provided statewide to help people remain in their communities and homes and to prevent admissions.

### WHAT WE DO



**Traditional Intermediate Care Facility/Intellectual or Developmental Disability (ICF/IDD) Services:** These services have been the core of LSTC for the past 100 plus years. They include 24-hour residential services and supports with medical and clinical programming and vocational services that provide individuals work opportunities on sites at the LSTC and throughout the Grafton community.

Home and Community-Based Waiver Services (HCBS): A variety of person-centered services where care is delivered in a person's home and community. Services address the needs of people with functional limitations who need help with everyday activities like getting dressed or bathing.

**Statewide Crisis and Support Services:** The goal of these statewide crisis services for persons with disabilities, their families and providers is to help people to be successfully supported in order to remain in their communities.

**Residential Crisis Units:** Future goal is to create youth and adult crisis units that can provide both short-term crisis support and transitional stabilization services for adults and youth.

#### TRANSITIONS

⊙ In 2005, the Department of Human Services executive director convened a task force to prepare a plan in response to the mandate in House Bill 1012, Section 16, to transfer appropriate center residents to community settings.

• The center's superintendent chairs the task force, which includes other department staff, developmental disabilities services providers and advocates.

• Prairie View Building - (DHS Northeast Human Service Center uses space. Kids Express Daycare, and Data Dynamics lease space).

⊙ Sunset Building - (Catholic Charities, Protection and Advocacy of ND and Upper Valley Education lease space).

⊘ New Horizons - Adventures Plus Daycare.

• Cottage 3 - (Leased to individuals with developmental disabilities who are supported by a private provider).

⊘ Cottage 6 - (Leased to LSTC who supports individuals through residential rehabilitation waiver services).

• The New Horizons Building is underutilized.

⊘ The Prairie View building and third floor of the Professional Services Building are underutilized.

⊘ North A and North B - (Sold to Metro Plains and converted to private apartments in 1999).

⊘ Buildings north of School Road - (Sold to Grafton Park Board in 2011).

#### BUILDINGS RECENTLY DEMOLISHED

⊘ The Pleasant View and Refectory buildings were demolished in 2020.
