REPORT OF YEAR THREE STATISTICS PROVIDED AND ACCEPTED BY HRSA SEPTEMBER 30TH, 2020- SEPTEMBER 29, 2021

• Number of Primary Care Providers trained through ECHO Sessions in 2021: There were 52 Primary Care Providers that attended the ECHO sessions.

• Number of BH providers that participate in ECHO Sessions in 2021: There were 56 Behavioral Health Providers that attended the ECHO sessions.

• **Total number of trained through ECHOs in 2021:** There were 237 people trained through the ECHO series of 2021. These people include, RN's Pediatricians, Nurse Practitioners, Physician Assistance, Social Workers, Patient Care Navigators, Counselors, and others unspecified.

• **Symposium attendees:** There were 136 unique professionals that attended the symposium on September 23rd, 2021.

• Total Trained in 2021: There were a total of 270 unique professionals trained by the PMHCA Program in 2021.


- Pediatric Mental Health Care Consult Line: Initiated in March 2021
 - Completed Primary Care Consultations: There were 38 pediatric consultations completed by the PMHCA team in 2021; this allowed

 - Completed Primary Care Consultations: There were 38 pediatric consultations completed by the PMHCA team in 2021; this allowed the pediatric patient to stay close to home and avoided a referral to specialty care waiting lists.
 Primary Care Providers who access the consult line have been provided pediatric mental health diagnostic education, screening tool education, guidance on medication adjustments/changes, and referral recommendations for therapy.
 In addition to providing consultation and training, there were 17 families that received care coordination and assistance to fulfill social determinants of health (gas, heating, food assistance, childcare, care referrals and coordination) from Family Voices of North Dakota, a team member of the ND PMHCA program. Throughout the six months of data collection (March 2021 to September 2021) there were 100 referrals provided to assist in the care coordination efforts of Primary Care providers for their patients.
- **Direct Patient Consultation:** After a completed consultation between the Primary Care Provider and PMHCA team member, two patients and their families were seen via telehealth by a psychiatrist member of the PMHCA team.
- Pediatric Mental Health Care Access Website: Launched in March of 2021; Promotion of free and accessible Pediatric Behavioral Health Screening tools are on the website: www.ndpmhca.org
- CAP of coffee: Child and Adolescent Psychiatry Coffee hour from 7:00-8:00 a.m. CST, on the second and fourth Wednesdays of the month began in June 2021, have generated 5 consultations

PMHCA YEAR FOUR PLANS WITH CARRYOVER

The ND PMHCA program received the full carryover amount requested from prior years unspent funds: These funds will supplement our existing yearly plan with the following activities:

The following is a list of activities scheduled for completion prior to Sept. 29, 2022

- 1. A professional recording of Dr. Nicola Herting demonstrating the ACES and MN Trauma screening administration and scoring. This video can be used for Primary Care Providers, Clinicians, CPS workers on demand training. Scheduled May 26th.
- 2. Dr. Dee Bigfoot, to provide training to a group of clinicians/therapists, involved in a different grant from SAMHSA, on a Native American culturally enhanced therapy called Honoring the Children Mending the Circle. Dr. Bigfoot is the only person providing this training in the country. Dr. Bigfoot last provided this training in North Dakota in 2009. Planned for June 2022.
- 3. Dr. Ross Greene is providing a free, two-day training on Collaborative and Proactive Solutions on August 18 & 19. Geared for anyone who works with youth (educators, parents, clinicians, primary care, psychiatry)

- ND PMHCA is having its own website created instead of continuing as a project under the Center for Rural Health. This will help web users navigate the page easier to find resources. How to Make A Consult Line Call

To access the Consult Line, Primary Care Providers can call the toll-free phone number: (888) 522-965, Monday through Friday between 8:30 am – 4:30 pm.

Providers will be asked a few brief questions to identify the nature of the call and to collect key points about the patient. The collected information will be forwarded to a Child and Adolescent Psychiatrist who will then call the Primary Care Provider back to provide a free consultation on the case.
