Dear Tribal Consultation Members:

This letter is regarding the Tribal Consultation between the North Dakota Department of Human Services and the North Dakota Indian Tribes. The consultation process was established to ensure Tribal governments are included in the decision-making processes when proposed changes in the Medicaid or Children's Health Insurance Program(s) will directly impact the North Dakota Tribes and/or their Tribal members.

Behavioral Health Services

Effective on or after July 1, 2022, North Dakota Medicaid will be submitting a State Plan Amendment to add Licensed Professional Counselors as an Other Licensed Practitioner (OLP), which will enable them to bill for any Medicaid-covered service that is within their scope of practice. As an OLP, LPCs will be eligible to receive an encounter payment for behavioral health services rendered at federally qualified health centers and IHS facilities and Tribal 638 facilities.

Medicaid Provider Rate Increases

Most Medicaid-covered services will receive a .25 percent inflationary increase effective for dates of services on or after July 1, 2022 as authorized and appropriated by the 2021 Legislative Assembly.

There will be no change to the Tribal 638 programs Indian Health Services all-inclusive rate as a result of these increases. Services reimbursed outside of the all-inclusive rate (e.g. non-emergency medical transportation) will receive the inflationary increase of .25 percent, as authorized by the 2021 Legislative Assembly.

Inpatient Hospital Services

Effective on or after July 1, 2022 North Dakota Medicaid will be submitting a state plan amendment to update to 3M[™] APR DRG version 37 for in-state prospective payment system (PPS) hospitals.

PRTF Practitioners

Effective on or after July 1, 2022 North Dakota Medicaid will be submitting a state plan amendment to update the list of practitioners who can order physical restraints in a psychiatric residential treatment facility. The practitioners listed will be consistent with North Dakota Administrative Code 75-03-17 updates.

MEDICAL SERVICES

Other Proposed Changes

In accordance with state plan authority, effective for dates of service on or after July 1, 2022, the rate paid for non-commercial, passenger vehicle non-emergency medical transportation mileage will be adjusted to reflect limits established by the North Dakota Legislature.

In accordance with state plan authority, effective for dates of service on or after July 1, 2022, the rate paid for meals will be increased to an amount that will not exceed the limits established by the North Dakota Legislature.

In accordance with state plan authority, effective for dates of service on or after August 1, 2022, the Medicaid Fee Schedule for vaccines will be updated will account for annual adjustments to the Average Sales Price or Wholesale Acquisition Cost.

Correct Coding Initiative

North Dakota Medicaid follows the National Correct Coding Initiative (NCCI) Edits. These edits were developed by the Centers for Medicare and Medicaid Services (CMCS) based on coding conventions defined in the American Medical Association's Correct Procedure Terminology Manual, national and local polices and edits, coding guidelines developed by national societies, analysis of standard medical and surgical practices and a review of current coding practices. CMS annually updates the Medicaid NCCI Policy Manual and the Medicaid NCCI Technical Guidance Manual.
