#### Why the Advisory Board:

- The BeYOU Health Board will provide recommendations regarding the LGBTQ2+ health issues and topics to the North Dakota Department of Health. Board members will also assist the NDDoH in ensuring the LGBTQ2+ perspectives on incorporating and planning the decisions for the state, as well as community partnerships. The BeYOU Board will also incorporate the seven components, which are led by representation of the LGBTQ2+ community, and maintaining consistent and structured meetings, fostering community building, offer a safe place for the LGBTQ2+ to share their opinions on health-related matters, describe the unique needs of the LGBTQ@+ community, analyze workplace community and healthcare settings that presents biased descriptions, and emphasize on planning, executing and focusing on the meaningful projects and topics to help improve the well-being and minimized the health inequities in the LGBTQ2+ communities.
- The Board will consist of 21 individuals who represent the LGBTQ2+ community, that reside in North Dakota or in the realm of North Dakota. The Board will consist of a diverse group that will represent various backgrounds. All members will be asked to commit to at least two years of service. Meetings will be in person, by phone or via Teams.

  - Speak with one voice after a decision is made unified voice.

- HIV decriminalization
- Collective advocacy
- Transgender health care needs

- Health disparities within hospitals/medical field.
- Mental Health services for the LGBTQ and homeless youth
- Screening for sexual health and gender orientation to be standardized in pediatric and family care
