Multidisciplinary clinics sponsored or supported by Special Health Services (SHS) are intended to provide access to pediatric specialty care and enable families to see many different medical providers and health care professionals in one place at one time. Families that attend the clinics are provided with:

- Information, education, and reassurance
- Diagnostic evaluation and/or treatment
- Coordinated, comprehensive care
- Follow-up and monitoring
- Access to specialty medical care

Please note that some of the clinics listed in this booklet are self-identified multidisciplinary clinics and may not be run in the same manner as those supported or sponsored by SHS. The listing of pediatric specialists in this booklet is obtained from other specialty agencies and does not guarantee acceptance of SHS enrolled clients.

# SPECIAL HEALTH SERVICES

## MISSION

SHS has a mission to promote a system of care and services that improves the health and well-being of individuals with special health care needs and their families.

Cross-cutting implementation strategies at the heart of all SHS programs include:

- Care coordination
- Collaboration
- Data-informed decisions
- Information and education

## PROGRAMS AND SERVICES

### COORDINATED SERVICES PROGRAM

The Coordinated Services Program provides services and resources that support coordinated management of specific chronic health conditions.

Services within this program include:

- **Metabolic Food** – Provides formula and low-protein modified food products for individuals with Phenylketonuria (PKU) and Maple Syrup Urine Disease (MSUD). Age requirements apply.
- **Multidisciplinary Clinics** – Families are able to see many different medical providers and health care professionals in one place at one time. The seven types of clinics available through SHS include:
  - Asthma
  - Autism
  - Cleft Lip/Palate
  - Developmental Evaluation
  - Metabolic Disorders
  - Myelodysplasia
  - Neurodevelopmental Coordinated Care
- **School Nurse Consultation** – Supports school nursing initiatives and promotes the connection between health and academic achievement by ensuring nursing care is safely and effectively delivered to schools, particularly in rural communities.

## FINANCIAL COVERAGE PROGRAM

The Financial Coverage Program helps families pay for medical services for eligible children, youth, and young adults who require specialty care to diagnose and treat their chronic health conditions.

Services within this program include:

- **Diagnostic Services** – Provides coverage for services that promote early diagnosis of SHS eligible medical conditions to all children who meet medical and financial eligibility criteria.
- **Treatment Services** – Provides coverage for services to children with chronic health conditions who meet medical and financial eligibility criteria.
- **Russell Silver Syndrome** – Provides coverage for growth hormone treatment and medical food.

## NEWBORN SCREENING AND FOLLOW-UP PROGRAM

The goal of this program is to identify conditions at an early age when treatment and intervention can prevent health problems, support early development, and save lives.

Newborn screening consists of three simple tests:

- **Blood Spot** – Newborns are screened for over 50 genetic and metabolic conditions.
- **Hearing Screening** – Newborns are screened for hearing loss.
- **Pulse Oximetry Screening** – Measures the amount of oxygen in a newborn's blood and can identify serious heart problems. This is also known as Critical Congenital Heart Disease (CCHD) screening.

For infants with a condition identified through newborn screening, follow-up is available to ensure the child receives services that support their health, growth, development, and overall function.

## CHILDREN WITH SPECIAL HEALTH CARE NEEDS SYSTEM ENHANCEMENT PROGRAM

Improves health outcomes of children with special health care needs (CSHCN) by advancing a quality, comprehensive system of care that promotes the healthy development and well-being of children and their families.

Six core outcomes that describe the system of services for CSHCN include:

- Family professional partnership
- Medical home
- Adequate health insurance
- Early and continuous screening and surveillance
- Easy-to-use services and supports
- Transition to adult health care

## SHS FINANCIAL COVERAGE PROGRAM

The SHS Financial Coverage Program provides coverage for services that promote early diagnosis and treatment to children with special health conditions that meet eligibility criteria.

### ELIGIBILITY CRITERIA

- Child must be a North Dakota resident.
- Child must be birth to age 21.
- Child must be medically eligible. The child must have, or may potentially have, a special health care need. A child is medically eligible if he or she has a condition that is included on a list of more than 100 eligible conditions treated under the Financial Coverage Program. A partial list of the most common eligible conditions covered are listed on the next page. A full list of eligible conditions can be found at:

- Family must be financially eligible. A family is financially eligible at 185 percent of the federal poverty level. See income guidelines chart below.

### INCOME GUIDELINES EFFECTIVE 5/1/2022

Gross income is generally used to determine financial eligibility. Adjusted gross income is used in instances of self-employment. Financial eligibility is determined annually. If family income is above the federal poverty level, a child may still be eligible with a monthly cost share which has a maximum amount of \$3000/month. This means that the family must spend a designated amount for out-of-pocket medical expenses for the family unit before SHS will pay for care or services for the eligible child.

## IMPORTANT FACTS

- If both financial and medical eligibility is present and treatment is planned, the application is approved for the specific medical condition. Effective date for services may be up to 90 days before the application, when needed.
- To ensure high-quality care, eligible children must receive services from a specialist who is approved to provide care under SHS. A list of North Dakota specialists who have met the standards is established and available from SHS.
- Payment for services is coordinated by SHS staff with other available sources of healthcare coverage.
- Restrictions of coverage may apply for certain services or eligible conditions.
- Covered services are any services that may be considered payable per SHS policy.

## CLEFT LIP AND PALATE CLINIC

For many children with cleft lip and palate, evaluation by an experienced team of professionals is necessary for an accurate diagnosis and optimal treatment planning. Families are an essential partner with the healthcare team as they are the principle caregiver and the center of strength and support for the child. SHS provides cleft lip and palate clinics in Bismarck, Fargo, Grand Forks, and Minot. Cleft lip and palate clinics supported by SHS provide multidisciplinary team evaluations where families have an opportunity to see many different providers in one place at one time. Reports generated from the clinic visit include recommendations to help direct care for the coming year. All children who might benefit are eligible to attend with *no* direct cost to the family. ## Shriners Outreach Clinics

### Shriners Healthcare for Children® - Twin Cities Outreach Clinics

A medical team including pediatric orthopedic surgeons, nurses, orthotics and prosthetics staff from Shriners Healthcare for Children – Twin Cities in Woodbury, Minnesota, travels to The Bone & Joint Center in Bismarck to diagnose and treat children (under age 18) with pediatric orthopedic and musculoskeletal medical health concerns. Typically, there is an outreach clinic held every other month. Please call to verify the upcoming outreach clinic date and time and schedule an appointment.

In some cases, following the outreach clinic, the Shriners medical team will recommend that the child receives additional services available at the Shriners Healthcare for Children clinic in Minnesota. Assistance with transportation and lodging expenses is available through Kem and El Zagal, North Dakota's Shrine Centers. Shriners staff will help families to connect with those resources

While a physician referral is not required to schedule an appointment at Shriners Healthcare for Children, it may be necessary to obtain care, depending on the service. Shriners Healthcare for Children – Twin Cities will see patients regardless of their insured status or type of insurance. They work with the families, their home doctor/primary care physician and insurance network to get the most coverage available. If there are cost concerns above and beyond that, families can work with the Shriners Healthcare for Children – Twin Cities financial advisor to request of additional assistance.

For over 97 years, Shriners Healthcare for Children – Twin Cities has been specializing in the treatment of children with pediatric orthopedic conditions. The clinic in Minnesota is part of a network of 22 Shriners Healthcare for Children locations throughout the United States, Canada, and Mexico.
