III. Update from CRC Leaders-

- a. **Tim Nikolai-** Working with FBLA to be more Cardiac Emergency response ready for their local school district. Shared link for American Heart Month 2025 External Toolkit
 - b. **Kari Enget-** Have started their intensive CPR training for their school for teachers, and the students will be following later in March. They also added another CPR instructor.
 - c. **Kathy Lonski-** Have upcoming Save A Life event this coming Saturday with paramedic students and NDSCS to lead it and expand it to include Stop The Bleed.
 - d. **Kay Zirnelt-** They got the grant for AEDs for the building where she lives, which is for those aged 62 and above, from the list of grants Christine sent previously.
 - e. **Tony Burke-** Has over 1,000 bills working through. South Dakota has now looked at doing CRC designations for colleges as well. Helped to get amendments made to 1363 such as DHHS to be the ones to give oversight through this bill for DPI. Bill for high school students to optionally receive CPR certification did not pass due to past similar bills where the appropriated money for it was not used, and application process was not easy.

- **Stroke Conference-** In person conference is being tentatively held November 5th in Bismarck.
 - **Cardiac-** Cardiac advisory committee is being rearranged/reorganized. Applications can be found on Cardiac System of Care website.
 - **Cure The Day-** Met with representatives at the capital to discuss stroke centers and care, cardiac systems, cardiac ready communities.
