- 2) **Approval of Minutes**-Motion to approve minutes from May 4, 2023, meeting by Alana, seconded by Kathy. Minutes approved.
- 3) **Update from Christine Dept of Health:** 
  - a) **Stroke System of Care**-working on performance improvement projects. Shared BEFAST/FAST-ED algorithm. Laminated copies are available for all EMS services. Christine will work on a mail out of these. Stroke educational videos on website. Next project, working on public facing BEFAST standing poster.
  - b) **Cardiac System of Care**-working on Acute Cardiac Ready Hospital designation program. Includes registry to collect STEMI data. The Rural Health Care Outcomes Accelerator program provides registry to rural hospitals for free through June 2025. All North Dakota critical access hospitals (CAHs) qualify. Currently, have four CAH's and two tertiary centers enrolled in registry.
    - i) Part of designation for Acute cardiac ready hospitals is to provide feedback to EMS.
    - ii) Working on performance improvements with the data that is available to us prehospital and we're breaking that down into rural versus urban. Hope to identify where we need to focus our education and outreach.
  - c) **ND Cardiac and Stroke Conference**-Save the date for Cardiac and stroke conference went out and includes registration link. The conference will be held virtually. October 25 will be the cardiac focused day and 26 will be the stroke focused day.
  - d) **Helmsley**-will be purchasing PulsePoint AED Program. Must verify all the AEDs that are pending, and the ones already verified.
