- **Aprille** – Will be scheduling site survey for chest pain center accreditation this spring.

**Update from Christine, dept of Health** – Kayla Erickson is no longer the STEMI coordinator at Sanford Fargo. Erica Erck is no longer the STEMI coordinator at Trinity Minot. Danaka and Tamara will be representing Trinity in the interim.

### **Accomplishments of the task force:**

- Approved the cardiac certification program for STEMI receiving center designation.
- Held an Acute Cardiac Ready Hospital webinar for critical access hospitals, recorded that and created a power point that is available on our website.
- Worked on our Acute Cardiac Ready Hospital site visit material-application and agenda
- We also worked on a document for items to submit prior to a site visit.
- Developed a chart review form

- Completed an annual review of our Acute Cardiac Ready Hospital designation criteria
- Started our site visit tour question
- Completed our first Acute Cardiac Ready Hospital (ACRH) site visit and designated them
- We reviewed, revised and approved the North Dakota Cardiac Guidelines-added high sensitivity troponins and cardiac testing.
- Updated and approved the Acute Cardiovascular Emergency Medical Systems of Care advisory committee bylaws.
- Added money to our budget for the statewide cardiac registry and we budgeted that for the biennium-to help supplement the cost of the registry for both tertiary and critical access hospitals.

#### **Cardiac System goals for next year:**

- Awareness of ACRH designation
- Press release in November regarding Valley City being designated the first ACRH. Please share to help increase awareness of the designation program
- Hold the cardiac conference with continuing education
- Designate more STEMI referring centers as ACRHs
- Create a STEMI referring and receiving centers state map
- Create a STEMI/cardiac coordinator orientation manual
- Case reviews to the task force meetings. Aprille agreed to bring one to the next meeting.

Legislature is in session now. In 2022, we submitted technical corrections to the governor-some approved. The ACTION registry no longer exists. The sentence specifying the ACTION registry in the Century Code was removed. SB 2085.

- 2023 Hospital recognition criteria is now out.
- They are moving beyond STEMI and NONSTEMI to capture the entire gamut of cardiac care
