- 4. Update for DHHS EMS, Christine Greff-
 - Ambulance districts have been mandated
 - Have been awarded an additional 7 million dollars for Rural Assistance Grants. Used for operations including staffing and equipment.
 - Trauma Program is offering CALS and TNCC courses
 - EMS for Children Program-new Andi the ambulance, remote controlled ambulance, available for kid friendly community events
 - Christine is working on the next addition of the EMS Unit newsletter

- Bylaws and quorum discussed
 - Need 2/3 majority to vote on changing bylaws
- Currently have 17 members, we need 9 voting for a quorum (majority)
 - o Difficulty meeting quorum at last several meetings
- Tony suggested alternate delegation. Will add alternative delegation into the bylaws. The delegate chosen needs to be identified.

Registry Discussion-

- Lots of discussion on statewide registry
- Christine provided State Cardiac Registry FAQ
- Facilities may use the registry they prefer but must share data into statewide registry if they would like to be designated
- GWTG-CAD currently 100% reimbursed by state
- Discussed Rural Health Care Outcomes Accelerator Program-all ND critical access hospitals qualify, plus rural Trinity-Minot

- Changes will be made to guidelines and physician attestation letter sent to coordinators to have cardiologist review guidelines and approve

8. Review Prehospital Quality Metrics-

- ESO cardiac data from the previous 180 days
