

# North Dakota EMS for Children (EMSC) Pediatric Emergency Care Coordinator (PECC) Program for Hospital Emergency Departments

#### What is a PECC:

A Pediatric Emergency Care Coordinator (PECC) is an RN and a Physician (in smaller facilities an Advanced Practice Provider may fill the role) team within the emergency department who ensure that its providers are prepared to deliver the best care for ill and injured children.

### **Background:**

Studies show that 80% of children are treated in general emergency departments, *not pediatric specific EDs*, increasing the need for **every** ED to be pediatric ready. Striving to make sure every ED is pediatric-ready results in decreased mortality in children. Having a physician and RN PECC in the ED increases scores on the National Pediatric Readiness Project assessment (NPRP) by 19 points. This <u>NPRP</u> assessment is now part of ACS requirements for trauma designation.\*

Incorporation and utilization of a PECC team is the single most important step for enhancing pediatric care in the ED and is recommended by the following organizations:

- American Academy of Pediatrics,
- American College of Emergency Physicians,
- American College of Surgeons,
- Emergency Nurses Association,
- Emergency Medical Services for Children Program,
- National Academy of Sciences,
- National Association of State EMS Officials,
- National EMS Advisory Council.

#### Intent:

North Dakota EMSC's intent is to ensure the best care possible for pediatric patients in our state by assisting North Dakota general emergency departments in establishing a PECC team, with the following responsibilities:

### **Physician or Advanced Practice Provider**

- Maintain competencies in pediatric-specific care by being current in PALS or APLS
- Provide pediatric skills and knowledge of provider team
- Obtain appropriate pediatric specific equipment, supplies, and training
- Assist in the development and review of ED specific policies and protocols to ensure inclusion of or specific to children
- Participate in pediatric quality improvement

#### RN

- Maintain and role model competencies in pediatric-specific care by being current in PALS or NRP or ENPC
- Assist with pediatric specific protocols and policies in the emergency department
- Provide pediatric continuing education opportunities
  - EXAMPLE-Conduct one pediatric simulation exercise annually
  - EXAMPLE-Encourage 75% of nursing staff to be current in PALS
- Oversee pediatric process improvement initiatives
  - EXAMPLE-Do at least five chart reviews monthly to track the percentage of patient with weights recorded in kilograms (this should be 100%)
- Ensure the availability of pediatric medications, equipment, and supplies
  - EXAMPLE-Do a scavenger hunt at least twice annually to ensure staff can readily access pediatric supplies and equipment
- Coordinate with other departments like Radiology and Lab to encourage pediatric care
- Promote family-centered care
- Conduct case reviews with appropriate feedback on pediatric calls/encounters
- Identify and incorporate pediatric best practices/evidence-based practices into standard pediatric care provision

"Children initially treated at trauma centers with the highest level of preparedness to care for children, called pediatric-readiness, are significantly less likely to die than those initially treated at trauma facilities with lower pediatric-readiness levels." \*\*
