

## FOOD AND LODGING LICENSE FEE SCHEDULE

- A **plan review fee** of 50% of the annual fee will be due when a plan review is required for new construction, remodel, change in operation, or as determined by Food and Lodging.
- An **initial license and application fee** is required for each new license application.
- An **annual fee** is required for each license being renewed. All licenses expire December 31st of each year except for temporary food service establishment licenses and vending licenses. Vending licenses expire on June 30th of each year.
