

Product Types

Types of usable marijuana under the North Dakota Medical Marijuana law are:

1. Dried Leaves and Flowers
2. Cannabinoid Concentrates or Extracts. Examples of concentrates include vapes, wax, shatter, budder, RSO, PDO, and FSO.
3. Medical Cannabinoid Products
 - a. Solutions
 - b. Capsules
 - c. Transdermal Patches
 - d. Topicals

Exceptions for Minor Patients (those under the age of 19):

1. Minors cannot have dried leaves and flowers
2. Minors cannot have any product with >6% THC

Purchase and Possession Limits

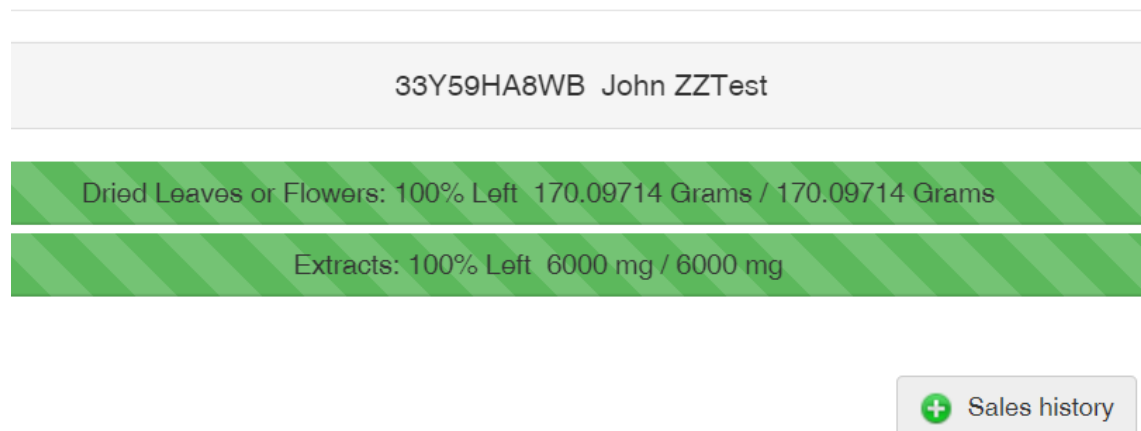
Patients and designated caregivers with a valid ID card can purchase the following in a 30-day period:

1. Up to 2.5 ounces dried leaves and flowers
**Enhanced Amount: patients with the debilitating medical condition of cancer may be authorized by their health care provider to purchase up to 6 oz. of dried leaves and flowers.*
2. Up to 6,000 mg THC total of other products

Patients can check their “**limit meter**” by logging into the registration system and clicking on the button that looks like a battery (see image below) on the top of the screen:



The limit meter looks like this:



There are three different possession limits for dried leaves and flowers: Standard, Enhanced or 0 (Zero). Cardholders can see what their possession limits are based on their ID card. The front of the card will indicate Standard, Enhanced, or 0 (Zero). The back of the card lists the possession limits for each category.

The front of the ID card will also state 'Other Products: Yes'. This is a reminder that all patients are allowed to purchase up to 6,000 mg of products other than dried leaves and flower.

The following tables can be used as a quick reference to determine who is allowed the different limits, what the purchase limit is, and what the possession limit is for each category.

Dried Leaves and Flowers Purchase and Possession Limits			
	Standard	Enhanced	0 (Zero)
Who	All patients 19 and older. Indicated on card as 'standard'.	Patients with the condition of cancer; authorized by healthcare provider. Indicated on card as 'enhanced'.	All minor patients (those under the age of 19). Indicated on card as 'no'.
Purchase Limit Within 30 days	2.5 ounces	6 ounces	Zero ounces
Possession Limit	3 ounces	7.5 ounces	Zero ounces

Other Products Purchase and Possession Limits	
Adult Patients 19 years and older	Minor Patients Under 19 years
Can purchase (within 30 days) up to 6,000 mg of THC	Designated caregivers can purchase on patient's behalf (within 30 days) up to

Possession: no limit	6,000 mg of THC. Pediatric product cannot be greater than 6% THC. Possession: no limit
