New HPV Vaccine Recommendations- Abbi Berg VFC Program Manager	Abbi Berg on the call and she is the program manager for Vaccines for Children at the ND Department of Health. She has been in the Health Department for 9 years. She has been in the VFC program for 4 years. New and exciting news with HPV vaccine:  3 current vaccines- HPV 2, HPV 4 and HPV 9. All 3 are available but by the end of the year only HPV 9 will be available. October 7, 2016 - FDA approved HPV 9 for a 2 series schedule. This will be given at 0 and 6 months. ACIP approved on October 17, 2016. This is a cost savings.  Healthy adolescents starting prior to their 15 <sup>th</sup> birthday are eligible for the 2 dose series. They will receive 2 doses with a 6 month interval. This does count for previous doses. Minimal requirement is 5 months. This will increase vaccine coverage levels and hope that it will increase

	rates also.  3 doses are needed for immune suppressed persons and if you initiate after the age of 15 need 3 doses series. The response to the vaccine is better under the age of 15 years old. It has not been published in the MMWR yet. It should be completed by the end of the month of December.  Some providers are using now and some are waiting for the formal publication. VIS has been updated- Abbi will be sending out. Minimal dose between 2 and 3 is 12 weeks minimal interval. IAC has not updated yet. They want all correct before it is published. 9 through 14 years 2 doses. Over 15 years they need 3 doses. It does not matter which HPV vaccine that they received.
Update from Kylie Hall	CDC grant - Danielle Pinnick will travel around the state to conduct HPV education with the new updated schedule. Danielle and her group will participate in about 100 visits.
