State Updates

Health Equity (Krissie Guerard) -

- Hired Covid Special Populations Coordinator Jorden Laducer who will start on August 11. Jorden lives in the Minot area.
- Will be getting another Public Health Associate from the CDC who will be working with NDDoH
 beginning in October and will be working primarily on health equity issues and assisting Tracy in
 the Office of the State Epidemiologist.
- NACDD has offered ND a \$25,000 mini grant. This grant will be used to promote racial justice and equity. Alicia will be leading that grant.
- The Office of Minority Health issued a grant that is due August 26. This grant offers funding up toward \$300,000 a year and will be for initiative to document and sustain disparity-reducing interventions. The Health Equity office will be working closely with the state epidemiologist office and their team.

Alicia Belay -

- Has two interns working for the DoH. Ahmad Makkaran will be working in the HE office. The
 other intern is working with indigenous community across the state and working on a telehealth
 project.
- DOT has reached out to get more input on putting on a Spanish speaking forum.

Website resources (Nicole Peske, Chief Communications Officer, NDDoH)

- Since there is a need for material to meet NFI needs, there will be a of task force to identify resources on an ongoing basis.
- Since Covid began, Nicole and her team have been working on getting messaging out to different groups and populations and are currently working to get a variety of resources translated into different languages.
- They also are exploring ways to make the NDDoH website more accessible to those who speak different languages.
- NFI members are influencers in their communities, therefore would be able to help with the process.

- Alicia is looking for NFI members who would like to be a part of the taskforce. The time commitment would be an extra couple of hours a month. Ahmed Makaraan will be leading the team as a part of his internship.

Community Assessment Process (Alyssa Altman) - Discussion on the best way to approach sensitive issues, like HIV, in NFI communities.

- The NDDoH is currently working on a plan to collect data for the integrate HIV and Viral Hepatitis Prevention and care plan, which will be in place for five years. In order to develop an appropriate plan, they have examined date to identify which populations are most affected by HIV, STDs and Hep C, and also have examined the literature to identify potential contributing factors of rates in ND.
- Now developing a Community Assessment to get a better understanding of how to reduce HIV, STD and Hep C in ND. In order to do this, they need to gather data across populations, including the NFI communities.
- In order to do this, they need a plan to include the needs of NFI communities and need to know how to best approach these topics in these communities.
- Ideas from the NFI committee include anonymous online surveys, 1:1 phones calls, inperson interviews, town halls, gift cards so that people feel they have an incentive to give their time.

Community Updates – NFI Board members to update the group on activities of their geographic area

- Grand Forks community seems to be using masks and being careful in public settings, yet not being as careful in social settings.
- Fargo Family Healthcare employees were tested for Covid-19 and it was posted on their social media sites in order to spread awareness. Covid response team has been helping many individuals by translating information to the community.
