

## Thermometer Guide for Prevention Partnership Providers

All prevention partnership providers are required to use a calibrated thermometer with certificate of traceability and calibration testing. In addition to this requirement, the Centers for Disease Control and Prevention recommends the use of a digital thermometer with detachable probe that best reflects vaccine temperature (e.g., a probe buffered with glycol, glass beads, sand or Teflon®). The glycol encased probe is preferred as it measures a liquid temperature which approximates the vaccine temperature in the refrigerator/freezer. Other recommendations for thermometers include the following specifications:

- Alarm system for out-of-range temperatures
- · Current, minimum and maximum temperature records
- Low battery indicator
- A thermometer which can provide continuous data monitoring information with user programmable recording interval at least every 30 minutes
- A thermometer display which can be placed outside the refrigerator/freezer to ease reading
- The calibration report of a thermometer tells the level of accuracy of the thermometer against reference standard. A thermometer with levels of accuracy of +/- 1°F/+/-.5°C is recommended.

## Certificates of calibration should fulfill either of the following four criteria:

- **Criteria 1:** The certificate must identify an ILAC/MRA signatory body accredited laboratory (A2LA, L-A-B, ACLASS, IAS, and PJLA) and has a model number, a serial number, date of calibration, and measurement results indicate unit passed test and documented uncertainty is within suitable limits (recommended uncertainty = +/- 1°F or .5°C). OR
- Criteria 2: The certificate must have a statement that the calibration testing conforms to International Organization for Standardization (ISO) 17025, has a date of calibration, serial number and model number and measurement results indicate unit passed test and documented uncertainty is within suitable limits (recommended uncertainty = +/- 1°F or .5°C). OR
- Criteria 3: Meets specifications and testing requirements for the American Society for Testing and Materials (ASTM) Standard E2877 Tolerance Class F (< +/-.5° C or < +/-1° F) and has a model number, a serial number, date of calibration, and measurement results indicate unit passed test and documented uncertainty is within suitable limits (recommended uncertainty = +/- 1°F or .5°C). OR
- Criteria 4: Traceable to the standards maintained by the National Institute of Standards and Technology (NIST) and has a model number, a serial number, date of calibration, and measurement results indicate unit passed test and documented uncertainty is within suitable limits (recommended uncertainty = +/- 1°F or .5°C).
