## KEY PRIORITIES FROM AUGUST 14th CHILDEN'S CABINET RETREAT

The Children's Cabinet of ND supports all children of North Dakota (pre-born to age 21)

The Children's Cabinet of North Dakota works to solve problems that impact children/families across systems by involving all involved parties.

What makes the Children's Cabinet different is the child centered/family focused approach that is comprehensive with participants from various systems including both vertical and horizontal representation.

The Children Cabinet works to streamline cross cutting services to ensure access and continuity by removing barriers.

The Children's Cabinet supports children and family's pre-diagnosis and before abuse or criminal charges through all levels of service/support needs.

## **Way Forward**

North Dakota Children's Cabinet

Mandates from S. B. No. 2313

### **GOALS:**

- 1. Develop strategies to address gaps or needs regarding early care and education, medical and behavioral health, community, child welfare, and juvenile justice;
- 2. Coordinate broad-based leadership across programs, agencies, branches of government, and tribal nations to meet the needs of children;
- 3. Seek strategies to provide services to children without consideration of prior engagement with juvenile services.

## **Engagement:**

- 1. Seek to engage cooperation across public and private service providers
- 2. Provide for the active participation of consumers and providers statewide on advisory committees;

#### Methods:

1. Receive information and recommendations from the department of human services, department of corrections and rehabilitation, and other state agencies.

## **ADD**

2. Determine the 2 or 3 major issues that require focus by Region in ND while continuing to *pursue Emerging issues* and breaking down silos

# An Idea/Concept

Adopt the concept of attacking/addressing a huge and seemingly complex set of issues across system barriers that would enable supporting the children of our State through Regional Groups.

The Practical Challenge: Difficult to plan/implement and manage 8 Regional Groups with simultaneous start-up or one Statewide configuration.

- 1. Manage process though two pilots
  - a) Urban
  - b) Rural with Tribal Region
- 2. Regional Pilot Setup/Organization
  - a) Establish Steering Group
  - b) Develop Regional Action/Outcome plans
  - c) What Do Families Need, in our Region?
  - d) What Needs State Action
- 3. Supply Regional Steering Group with:
  - a) Data Set (start with common elements in the data sets- add as local situation dictates)
  - b) Template for Conversation/Getting started
  - c) What we have learned, so far

### 4. Role of ND Children's Cabinet

- a) Design and Implement Pilots
- b) Operate Pilots for a Year
- c) Foster and nurture Partnerships with Regions and other players
- d) Serve as a platform for cross regional learning, innovation and conversations

## 5. What does that entail for the Children's Cabinet?

- a) Design the Conversation Template
- b) Minimum Data Set
- c) Supply ongoing Data Needs
- d) Facilitators for Regional Steering Groups??
