



OVERVIEW

SAMHSA's MHBG and SUPTRS BG provide states with the flexibility to design and implement activities and services to address the complex needs of individuals, families, and communities affected by substance use disorders and for adults with SMI and children with SED. The purpose of the block grant programs is to support services addressing these needs.

For the Secretary of HHS, acting through the Assistant Secretary for Mental Health and Substance Use, to make an award under the programs involved, **states must submit an application(s) sufficient to meet the requirements described in SAMHSA's block grant authorizing legislation** and implementing regulations sufficient for SAMHSA to monitor the states' compliance efforts regarding the obligation and expenditure of MHBG and SUPTRS BG funds.

Role of the Behavioral Health Planning Council

As identified in the By-Laws, one of the duties of the council is to:

 review and provide feedback on applications for the Mental Health/Behavioral Health Block Grants and any related stakeholder input into such applications, at least semi-annually.








Prevention and Early Intervention INDICATORS


- Decreased past month binge drinking rates among adults

- Increased availability of early intervention services for individuals with a marijuana related offense
- Development of a Suicide Fatality Review Commission

- Build capacity to certify Certified Community Behavioral Health Clinics (CCBHC)






Person-Centered Practice INDICATORS

- Expand awareness of American Indian culture among behavioral health providers
- Expand awareness of mental health in aging services providers
- Expand access to behavioral health services for highrisk professionals (i.e. Veterans, Law Enforcement, First Responders)
- Expand culturally-relevant mental health services to North Dakota tribal areas and New American, foreign-born immigrant (NFI) and refugee populations.







Increase Access to Targeted Services INDICATORS


- Increased implementation of evidence-based practices among behavioral health and healthcare providers serving pregnant women and women with dependent children.
- Withdrawal management
- Expand awareness of and access to residential services



Workforce INDICATORS

- Increase the infrastructure of the Substance Use Primary Prevention workforce in the State
- Expand peer support services
- Designate a single entity responsible for supporting behavioral health workforce implementation
