RE: Tribal Consultation on the 1915(c) Medicaid waiver Traditional IID/DD waiver amendment application

Dear Tribal Consultation Members:

This letter is regarding Tribal Consultation established between the North Dakota Department of Health and Human Services and the North Dakota Indian Tribes. This consultation process was established to ensure Tribal governments are included in the decision-making processes when changes in the Medicaid or Children's Health Insurance Program(s) will affect items such as cost or reductions and additions to the program.

This letter provides the opportunity for consultation on the proposed renewal of the Traditional IID/DD waiver.

The Department's Developmental Disabilities (DD) Section intends to submit a 1915 (c) waiver renewal to the Centers for Medicare and Medicaid (CMS). The current **Traditional IID/DD waiver** is approved for a five-year period and expires March 31, 2024.

Some of the proposed changes include: adding Respite as a stand-alone service; allowing participants of In-Home Supports and Respite to be authorized for provider managed and self-directed at the same time; allowing individuals who are not the primary caregiver, legal decision maker, or guardian that live in the same home as the participant to provide In-Home Supports and Respite; Environmental Modifications limit increased from \$20,000 to \$40,000 per waiver period (5 years); removing Parenting Supports; and allowing a participant to continue to receive Residential Habilitation, Independent Habilitation, In-Home Supports, and Respite services while admitted to a hospital setting to meet the needs of the participant that are not met through services that the hospital is obligated to provide.
