



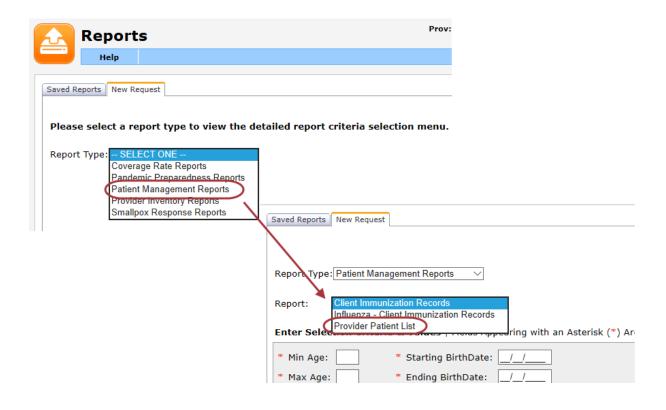

North Dakota Immunization Information System: Provider Patient List Report

The Provider Patient List report generates a list of all clients in the NDIIS that belong to your NDIIS provider site. A client is considered to belong to your provider site if your facility is their last provider visited, excluding for influenza vaccine, meaning your facility was the last to enter a non-influenza vaccine in the client's record in the NDIIS.

How To Run a Provider Patient List Report:

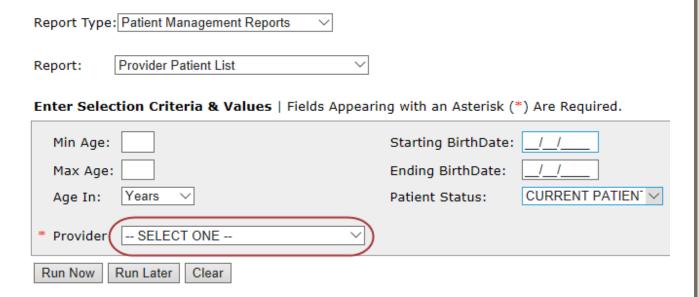
1.) The Provider Patient List Report is located under the Patient Management Reports report type in the NDIIS reports module



- 2.) Enter either a minimum and maximum age (in years or months) or a birthdate range for the age group of clients you want the report to include
- 3.) Select the **Patient Status** group you want the report to include
 - The report can be run to include only current clients (i.e., those clients that are still actively associated with your NDIIS provider ID) or all clients. If running the report for all patients, current clients as well as those who have their status set to MOGE or Lost to Follow-Up will be included in the list



4.) Select your provider site from the **Provider** drop-down list



5.) Click **Run Now** or **Run Later** to run the report

The completed patient list report shows the selected report criteria including: provider, age range and/or birthdate range and patient status. It then lists all clients that belong to the selected provider and are within the indicated age/birthdate range. The list of clients is organized in alphabetical order by last name, and then first name, and includes the client's name, birthdate, last vaccination date, and NDIIS record status.
